## The International Neurotoxin Association (INA)

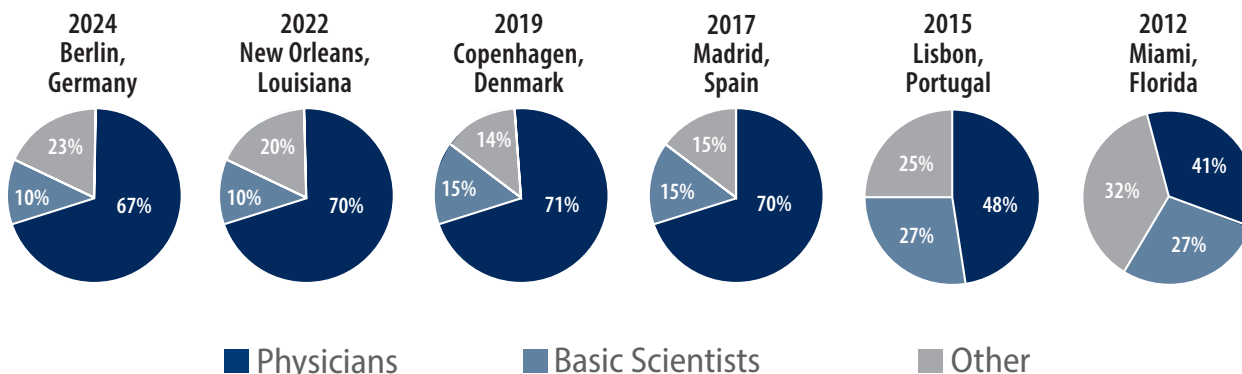

### Space Assignment and Fees

Space will be assigned according to the date on which both the contract and deposit are received, availability of requested space, special needs, and compatibility of exhibitors' products.

### Exhibitor Admission

Badges for exhibit personnel will be available for pick up on site at the registration area. Admission to exhibit hall is by badge only. Badges must be worn at all times.

### Installation

All exhibits must be set up starting Tuesday, 13 January between the hours of 8:00 and 23:00. The aisles must be cleared by 17:00 on Wednesday, 14 January without exception.

### Dismantling

All exhibit materials must be packed and ready for removal from the exhibit hall starting at 12:00 on Saturday, 17 January 2026.

### Security

Security service will be provided during move-in, move-out, and show hours, as well as after daily exhibit hours. The INA, the Madrid Marriott Auditorium Hotel & Conference Center, and the official security company are not responsible for any loss or damage to exhibitor property.

If written cancellation is received by the INA on or before Monday, 13 October 2025, a full refund will be granted, less €500 to be withheld as a cancellation fee. If the exhibiting company cancels after Monday, 13 October 2025, the exhibiting company will forfeit all payments made to the INA under this agreement, and the company will be held liable for the full amount of the cost of the exhibit space. 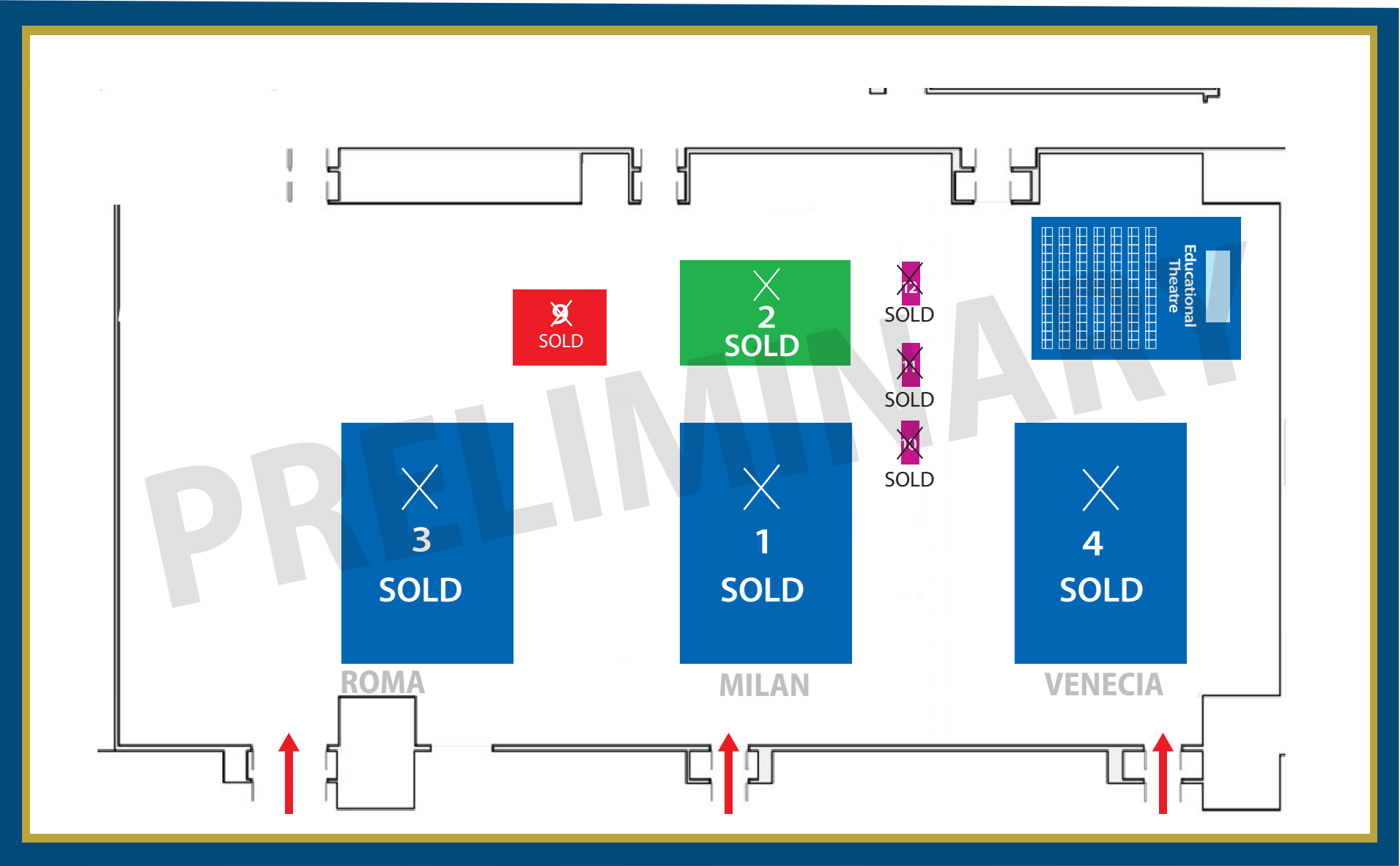
### Nonprofit Exhibit Space
